

## McBride Lake Campground Information

1. Camping Season is May long weekend to the week after September long weekend
2. Quiet Time is 11:00 pm to 7:00 am.
3. Use of unlicensed vehicles is strictly prohibited. IE: No ATV's, dirt bikes, golf carts, etc.
4. Pets must be leashed and attended to at all times. Pets cannot be left unattended in a campsite or camper. Pet waste must be cleaned up.
5. In an effort to keep a bear safe campground, campers must maintain their campsite by keeping it clean at all times, and packed away when not at the campground.
6. A) No parking vehicles or boat trailers in the boat launch or in public areas for more than 72 hours. We have storage available for a fee of \$1.00 per day.  
B) No long term shoreline boat parking is allowed, you must have a valid dock or stake down permit to be able to leave a boat in the water when you are not at the campground.
7. Generators are allowed only when in your site, do not leave a generator unattended due to fire risk. Generators are not permitted during quiet time 11:00pm-7:00am.
8. No further clearing or expanding of your site without first talking to us. If you have a tree on your site that is a concern, let us know.
9. Only household garbage is to be placed in the garbage cans and bins. All other garbage such as broken lawn chairs, tarps, cardboard, packing material, etc. is to be taken home with you.
10. Recycle bins for beverage containers, pop cans and bottles are available by the garbage bins.
11. A deck or an outdoor RV mat is allowed to a maximum of 400 sq. ft. and is not to extend more than 8 ft. (at a 90 degree angle) from the long side of a camping unit. All decks must be approved by us before construction. All decks must be against the camper, portable, have no railing and be easily removable. Decks must be ground level and have a maximum height of 2 feet. A "Slide-A-Deck" or other original factory-manufactured deck attached to the camping unit is exempt from the height and railing restriction. Decks must not be enclosed, covered or screened on any site by a home built frame. "Add-A-Room" structures or other equipment made and attached by the camping units original manufacturer are exempt from the "no enclosure" restriction. Mats are to be placed on a non-vegetated area unless an eco-friendly RV mat is used.
12. Accessory Buildings: One storage shed and one gazebo is permitted per campsite. The size is to be no larger than 100 sq. ft. All sheds must be approved by us prior to installation. Sheds must be properly maintained at all times. Paint or siding is to be in neutral colors to compliment campground aesthetics. Commercially purchased, blow-moulded plastic resin sheds and chests are allowed. Fabric covered storage structures will not be allowed. Firewood shelters are not considered an accessory building and must store less than half a cord (4ft x 4ft x 4ft).
13. Tarps are allowed, but the cumulative total of suspended horizontal tarps is not to exceed 400 sq. ft. The maximum area of any one horizontal tarp is 200 square feet. Awnings that are factory

attached to a camping unit and self-supported canopies or gazebos are to be included in the cumulative total area (400 sq. ft.) of the tarps. Screened dining tents are excluded from the cumulative total area of the tarps and only one screened tent is allowed per site. Tarps shall be suspended only over the defined/disturbed campsite area and shall not cover any outlying vegetation. There is to be no placement of vertical tarps for the purpose of site-screening. Tarps that are used, are to be green, brown or camouflage.

14. Trees must not be damaged. Do not attach anything to trees with nails or screws. Any tarps which are required to be attached to trees must be attached by bungee cords or similar elastic material. Ropes are not to be used in the hanging of tarps when attached to trees unless the rope is passed through a "sheath" with a smooth exterior (such as a rubber hose or plastic tubing) at the point of contact with the tree.

15. No portable garages or structures for the storage of boats or vehicles are allowed. No home-built frames or support structures for tarps are allowed. No supported, fixed-roof structures campers are allowed. It is prohibited to erect vertically-enclosed structures in campsites, with the exception of tents manufactured for the primary purpose of sleeping and habitation.

16. Potted plants are allowed. Planting in the ground and soil tillage is not allowed.

17. Grey water and sewage must be contained and disposed of at disposal sites. Disposal of grey water or sewage on the ground is prohibited.

18. Fencing around campsite is not allowed.

19. If you are unable to get to the campground to cut your grass, email us and we can do it for you for a fee of \$25.00 per cut.

20. Only 1 camping unit per site is allowed. The camping unit must be legally registered and display a current valid license plate at all times. One small tent is allowed for dependent children. All other guests must be registered with us prior to their stay.

21. If you have company coming for a short period of time and need to set up an extra tent or camper (providing your site has the space), a fee of \$15.00 per night will be charged. The tent or camper has to be removed when your company leaves.

22. McBride Lake Campground operates on park land so most of these requirements are stipulated by the Ministry of Parks, Culture and Sport and must be followed. A vehicle park pass should be displayed when in the park. Passes are free for seniors and are available for daily, weekly or seasonal use. Contact or visit a Sask Parks office for information. We do not administer passes.
